RELATING TO CO-OPERATIVE EDUCATIONAL EXCHANGE

The Convitto Nazionale "Paolo Diacono" of Cividale del Friuli, Italy (hereafter CNPD)

and

and the Sergey Andriaka Moscow State Academy of Watercolor and Fine Arts, Russia (hereafter ANDRIAKA ACADEMY),

consider the encouragement and development of co-operation and exchange in educational areas of mutual interests as desirable. Each party wishes to expand the basis for friendship and co-operative educational exchange between Italy and Russia. The CNPD (Italy) and the *ANDRIAKA ACADEMY*, have therefore set forth the understandings and desires in the Memorandum of Understandings.

With this Memorandum of Understanding, the CNPD and *ANDRIAKA ACADEMY* desire to establish a co-operation for educational exchanges.

1. PURPOSE OF EXCHANGE

The purpose of this Memorandum of Educational Co-operation includes, but is not limited to the following:

1.1

Both parties agree to encourage the secondary schools to cooperate in running joint schools or providing joint courses.

1.2

Both parties agree to encourage the establishment of sister ship school links between CNPD (Italy) and *ANDRIAKA ACADEMY* (Russia) which might include flexible forms of students and teachers exchange.

1.3

Both parties are willing to further strengthen the cooperation in education, and to expand the cooperation into all the fields of education.

2. EXCHANGES

Both parties agree to give the possibility for headmasters, teachers, students to visit the countries based on mutual arrangements.

2.1

To enhance the mutual understanding and communication, each party will welcome annual visits maximum 3 weeks delegations from the other party.

2.2

The visiting party will pay the costs of travelling and accommodation, local transportation, and other local hospitalities during the visit.

2.3

It will be possible to facilitate the visit of groups of students for short periods based on mutual arrangements.

3. BASIS FOR COOPERATION

Each party agrees that:

1. All discussions will be conducted openly and frankly with a view to providing mutually beneficial outcomes for each other.
2. Each will respect the reputation of the other party and appreciate the roles of the others at all times.
3. The objectives lead to long-term cooperation relationships.

The Memorandum of Understanding will come into effect on the date of its signature by both parties and will be evaluated every three years for any necessary revision. This Memorandum may be amended mutual agreement for both parties.
